00.0 NOTICE TO AMEND MOTIONS

To consider and if deemed fit, resolve by way of a Special Resolution pursuant to Section 29(1)(d) of the Building Maintenance and Strata Management Act 2004, that the incoming Management Council be empowered to purchase additional land betterment from Singapore Land Authority (SLA) at a cost not exceeding S\$150,000.00 (plus GST), and further empowered the incoming Management Council to appoint a building consultant and building contractor to design and build the New Management Office (Refer to Appendix 6) at a sum not exceeding S\$500,000.00 (plus GST), with a contingency of up to 20% of the approved sum, or such other sum as may be determined by the general body. The expenditure shall be drawn from the Sinking Fund on terms and conditions deemed appropriate by the incoming Management Council.

Explanatory Note: The current Management Office is on rental basis. Over time, paying rent is not cost-effective, as it provides no long-term value to MCST. To address this, the Management Council is seeking approval to build a new Management Office, which will save on rental costs and become a permanent asset for the estate. To proceed, the MCST needs to purchase additional land betterment from the Singapore Land Authority (SLA) at an estimated amount of \$150,000 (plus GST) to legally support the construction. This is a one-time cost that ensures compliance and secures the land for future use. The total

cost of the project, including design, construction and land betterment charge, will not exceed S\$500,000.00 (plus GST), with an added contingency of up to 20% for any unforeseen expenses. All costs will be funded from the Sinking Fund.

It was unanimously resolved to amend motion no. 10.0 as proposed.

Owners who park there pay parking fees to the Management Corporation.
