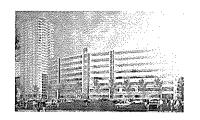

The lease is for one(1) year w.e.f 1 August 2018 to 31 July 2019, with the option to extend for another year at the same terms and conditions.

3.3 Lift Matters - AE Inspection

MA informed that the AE has inspected all the lifts except lifts PL1 and PL3 which is scheduled on 13 July 2018 Friday. They will submit the inspection reports to MCST and M/s Sigma Elevator will follow up with the reports.

3.4 Replacement of FCC Fire Panel

MA informed that the works has been awarded to the current contractor, M/s Unique Fire Protection at \$150,000.00 (inclusive of 7% GST). The contractor informed that the shipment from USA will arrive 2nd week of August 2018. They have to submit insurance for the replacement works. MA will also update SCDF of the replacement of main fire panel.

3.5 SCDF Issues – Appointment of QP (Architect)

The QP (Architect) is doing the documentation and obtaining the relevant drawings. They will update MCST on the progress. MA will update SCDF of the works.

3.6 Carparks' EPS Systems

MA has arranged a meeting on 13 July 2018, Friday at 2pm between the sub-committee and Sun Singapore Pte Ltd.

The Agenda is to discuss the existing car park system and suggested to include web portal and mobile apps whereby individual unit have to log in to file complaints, feedback and update car parking matters similar with HDB system. MCST will look at how to incorporate the interface template of the system proposed by Sun-Singapore Pte Ltd.

3.7 High Bay Lights Project

Council tasked MA to purchase a tender box, whereby 1 key will be given to council member and the other key to be kept in the management office.

4.0 Any Other Business

Car Parking

Info

Council deliberated and agreed on the following allocation of car parking for Wcega Tower & Plaza. It was also concluded to categorized vehicles above 5 tonne to be heavy vehicle and cannot park at Plaza rooftop due to safety reason. They can

only park within their own unit's red lots or beside the loading bay on a first come

first serve basis.

Tower

Season Parking (Free)

1) Up to 4 vehicles (car or lorry below 5 tonne) can be registered per strata unit.

Additional Season Parking (Chargeable)

- 1) Up to 2 vehicles (car or lorry below 5 tonne) can be purchase per strata unit at \$60.00 per vehicle per month or
- 2) Up to 1 heavy vehicle (lorry above 5 tonne) can be purchase per strata unit at \$120.00 per vehicle per month.

Plaza

Season Parking (Free)

1) Up to 4 vehicles (car or lorry below 5 tonne) can be registered per strata unit.

Additional Season Parking (Chargeable)

- 1) Up to 2 vehicles (car or lorry below 5 tonne) can be purchase per strata unit at \$60.00 per vehicle per month or
- 2) Up to 1 heavy vehicle (lorry above 5 tonne) can be purchase per strata unit at \$120.00 per vehicle per month.

Red Label (FOC)

1) Up to 4 vehicles (car or lorry below 5 tonne) can be registered per strata unit or 2) Up to 2 heavy vehicles (lorry above 5 tonne) can be registered per strata unit.
